Voting will take place from 3:00 PM to 8:00 PM at the Mattituck Park District Office, Veterans Memorial Park, 11280 Peconic Bay Boulevard, Mattituck, New York, for the purpose of voting on the proposed budget for the fiscal year 2025. Applications may also be obtained by visiting mattituckparks.com/vote. The completed absentee ballot application must be received by the District Clerk by 12:00 PM on the 1<sup>st</sup> of August 2024 if the ballot is to be mailed to the voter; or by 12:00 PM on the 14th of August 2024 if the ballot is to be delivered personally to the voter or his/her agent.

Voters must return completed absentee ballots either (1) by hand delivery to the Mattituck Park District office at Veterans Memorial Park no later than 8:00 PM on the 15th of August 2024; or (2) by mail postmarked by a governmental postal service not later than the 15th of August 2024 that is received by the Mattituck Park District no later than the 22nd of August 2024.

Every resident who shall have resided in the Mattituck Park District since July 16, 2024, and whose name and address is within the boundaries of the Mattituck Park District as set forth on the Suffolk County Board of Elections voter registration listing, shall be qualified to vote.
